Tenders should be submitted in sealed cover containing two separate sealed envelopes- Cover -1 for technical bid and the Cover-2 for price bid and both the covers should be put in Cover-III. On the date of opening of tender, only the technical bids will be opened.

All the covers must be superscribed with the tender number & date, date of opening and Cover number and are to be put into the tender box provided for the purpose.

1.Earnest Money: An amount of Rs. 15120.00 (Rupees Fifteen thousand one hundred twenty) only shall be deposited by the tenderers along with their quotations in the form of Bank Draft duly drawn in favour of 'ECL JHANJRA PROJECT, payable at Asansol. Earnest money deposit by unsuccessful tenderers shall be refunded immediately after finalization of tender. Earnest money of the successful tenderers will be refunded after successful execution of order. Earnest money will be forfeited if any tenderer fails to submit order acceptance within 15 days from the date of order.

2.Security Deposit: The successful tenderers will have to submit Security Deposit within (2) weeks time @ 10% of the value of the awarded contract with out having any ceiling in the form of bank draft. S.D will be refunded within 30 days after satisfactory execution of the contract. For unsatisfactory performance and/ contractual failure, the Security Money will be forfeited.

N.B.:If any State/ Central Govt. Organisation / PSU & Valid DGS&D/ NSIC Registered(for tendered items) Firm can produce documentary evidences issued by Govt. Authorities for according exemption towards submission of Earnest Money deposit/ Security Deposit, they may be considered for exemption from submission of Earnest money deposit/ Security Deposit.

3. The rate should be quoted on FOR, Jhanjra Area Store Basis.

4. The price quoted must be firm and valid for acceptance at least for six months from the date of opening of tender.

5. Firm delivery period should be specified.

6. Payment: 100%within 30 days after receipt and acceptance of the materials at our Jhanjra Area Store.

7. Manufacturer`s test certificate must be submitted along with the consignment.

8. Materials will be inspected by us at our site.

9. Please furnish VAT/Sales tax Registration No. ,PAN No., Banker`s name and address and Bank Account number. You have to submit the status / declaration of your firm as per the MICRO, SMALL & MEDIUM ENTERPRISES DEVELOPMENT ACT, 2006 along with the offer.

10. Guarantee/ Warranty: Eighteen months from the date of receipt of the materials at Jhanjra Area Stores or twelve months from the date of installation whichever is earlier against any manufacturing defects/ bad workmanship.

11. Fitment Certificate: - It must be guaranteed that the materials offered must fit properly on the above equipment with out any modification for which cause these are being purchased. A certificate in this respect is to be given at the time of delivery of materials.

12. The tenderers are requested to inspect the items on any working day at Jhanjra Project/ Area work shop before submitting tenders. They may get themselves fully conversant with our requirement/Technical specification/Systems drawings (whichever available), terms & conditions and other details furnished in the tender document so that no ambiguity arises thereafter.
13. The tenderers must give location and complete address of their works/their principal's works.
14. L.D may be imposed in case of late delivery @ ½% per week or part there of limited to maximum of 10% for the undelivered portion.
15. Delivery: To commence within one month @ 10,000 nos per month and to be completed within ten months.
16. The tenderer who will download the tender document from website must enclose demand draft towards tender fee along with their offer.
17. The tender may be opened in the next working day in case the same can not be opened on the scheduled date due to some unforeseen circumstances like Bandh/ strike/holiday etc.
18. Tender papers may be supplied free of cost on demand to all Govt. Undertaking / Ancillary units of ECL/NSIC registered firms for the same item.
19. PRICE FALL CLAUSE: It will be the condition of the contract that all through the currency of the said contract, the price at which the stores will be supplied shall not exceed the lowest price charged by you to any other agency including DGS&D, New Delhi. In the event of price going down, you shall promptly such information to enable ECL to amend the contracted rates for subsequent supplies.
20. Risk Purchase Clause: In the event of failure to deliver the materials within the stipulated period Jhanjra Area, ECL has the right to purchase the materials from other sources with due notice and at the risk and cost of the defaulting supplier.
21. L-1 Bidder will be decided on the basis of Price valuation(landed cost) which includes basic price, taxes and duties, packing and forwarding, freight, insurance etc. CENT VAT credit as applicable will be considered.
22. The bidder has to give a declaration that they have not been banned or delisted by any Govt. or quasi Govt. Agencies or Public Sector Undertakings. This fact must be clearly stated. If declaration is not given the bid will be rejected as a non-responsive. Company's guideline will be followed in this regard.
23. Quotation erased and overwritten will be summarily rejected unless corrections are authenticated with the tenderer's signature. Hand-written and faxed quotations are liable to be rejected. All the pages of tender document should be signed and have company's seal.

IMPORTANT PARAMETER FOR QUALIFYING IN TECHNICAL BID.
